**Precautions in connection with Fire** rupture/explode.  
Fire fighters should wear Self-Contained Breathing Apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. Water spray may be used to cool down heat-exposed containers.

## 6. ACCIDENTAL RELEASE MEASURES

**Emergency Procedures** Wear appropriate personal protective equipment and clothing to minimise exposure. Increase ventilation. If possible contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain. Dispose of waste according to federal, Environmental Protection Authority and state regulations. If the spillage enters the waterways contact the Environmental Protection Authority, or your local Waste Management Authority.

## 7. HANDLING AND STORAGE

**Precautions for Safe Handling** Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Avoid inhalation of vapours and mists, and skin or eye contact. Maintain high standards of personal hygiene ie. Washing hands prior to eating, drinking, smoking or using toilet facilities.

**Conditions for Safe Storage** Store in a cool, dry, well-ventilated area, out of direct sunlight. Store in suitable, labelled containers. Keep containers closed when not in use. Ensure that storage conditions comply with applicable local and national regulations.

**Corrosiveness** Not corrosive to aluminium.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**National Exposure Standards** No exposure standards have been established for the mixture by the National Occupational Health & Safety Commission (NOHSC). However, over-exposure to some chemicals may result in enhancement of pre-existing adverse medical conditions and/or allergic reactions and should be kept to the least possible levels.

**Biological Limit Values** No biological limit allocated.

**Engineering Controls** Provide sufficient ventilation to keep airborne levels to least possible levels. Where vapours or mists are generated, particularly in enclosed areas, and natural ventilation is inadequate, a exhaust ventilation system is recommended.

**Eye Protection** Safety glasses with side shields or chemical goggles should be worn. Final choice of appropriate eye/face protection will vary according to individual circumstances. Final choice of appropriate gloves will vary according to individual circumstances i.e. methods of handling or according to risk assessments undertaken.
